

Notice for proposal hearing (fall 2022)

1. Deadline for application: November 30, 2022
2. Documents to submit
 - (1) Transcript-- Students may apply for proposal hearing after fulfilling all the required credits. The transcripts can be re-submitted to the department office on the school start day of September if you are still taking courses this semester.
 - (2) Consent for thesis guidance (attachment I)
 - (3) Application form for proposal hearing (attachment II)
3. The thesis advisor should be full-time teacher in English Department, NTNU, and cannot be a retired or part-time teacher. If there are special circumstances, the case should be send to the department curriculum committee for discussion.
4. About thesis proposal
 - (1) Format: more than 15 pages (references included), Times New Roman, font size 12, double space, including the four parts below
 - 1) literature review
 - 2) methodology
 - 3) initial bibliography
 - 4) expected findings
 - (2) The thesis proposal should be reviewed by the advisor preliminarily.
 - (3) Proposal hearing: e-mail the information (the blue part below) to Tzuyi when you confirm the date with your advisor
 - (4) Committee member: 2-3 (professors, associate professors, or assistant professors in related fields)
 - (5) If you plan to graduate in January 2023, then
 - 1) Deadline for proposal hearing: November 20, 2022
 - 2) Deadline for applying for oral defense: November 30, 2022
 - 3) Deadline for final defense: January 30, 2023
 - (6) If you plan to graduate in July 2023, then
 - 4) Deadline for proposal hearing: April 20, 2023
 - 5) Deadline for applying for oral defense: April 28, 2023
